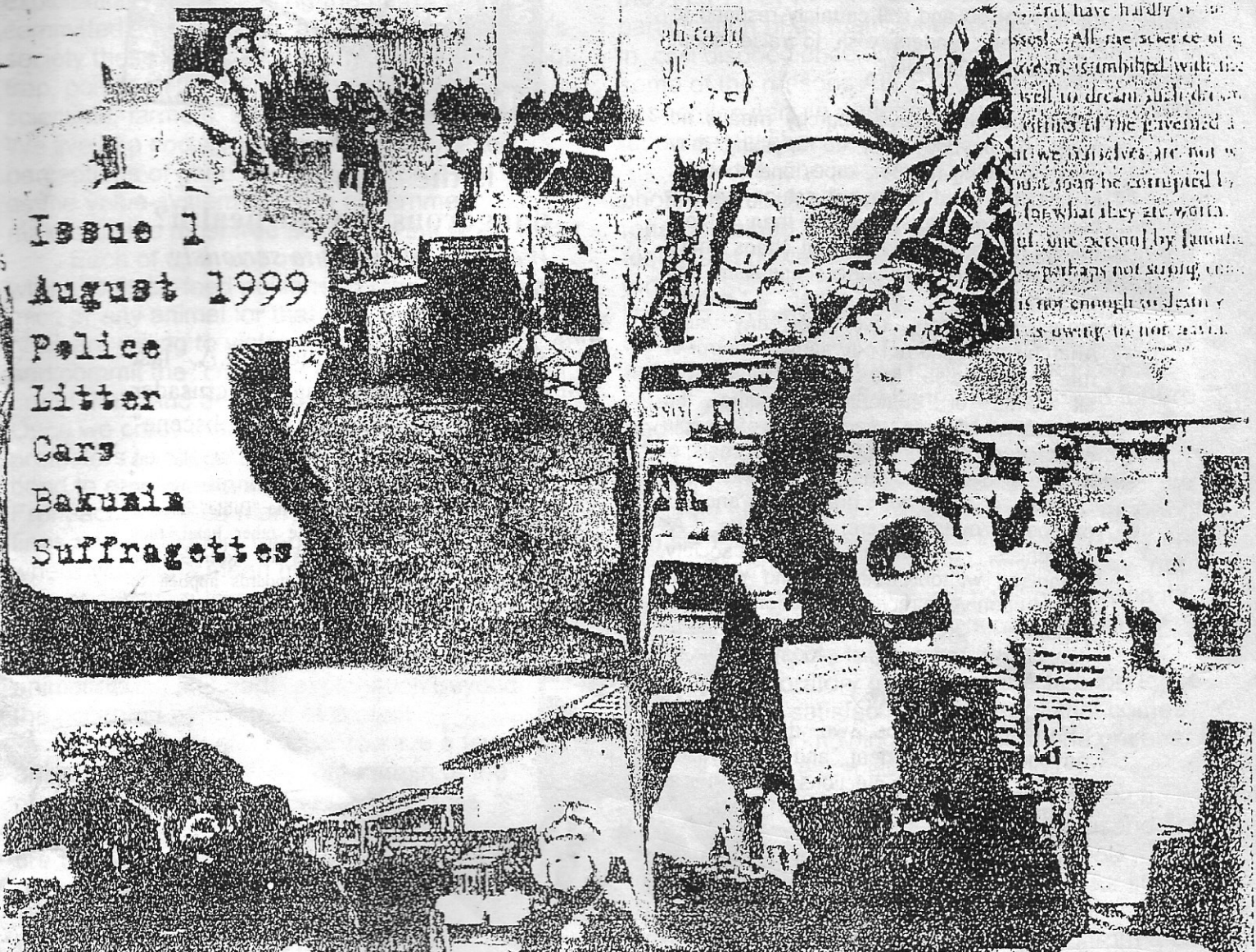

Animal Liberation: IF NOT YOU, THEN WHO?



In today's society, those who rescue animals from places of abuse and cause economic damage to institutions of earth and animal

exploitation while revealing the horror that is committed against them, are terrorists. In today's society those who burn, maim, electrocute, shoot, trap, poison and torture animals are sportsman, scientists, farmers, and businessmen and women. We live in a society where these convoluted perceptions of good and bad are force-fed to us as the value-system that the government claims makes us the most free society in the world today.

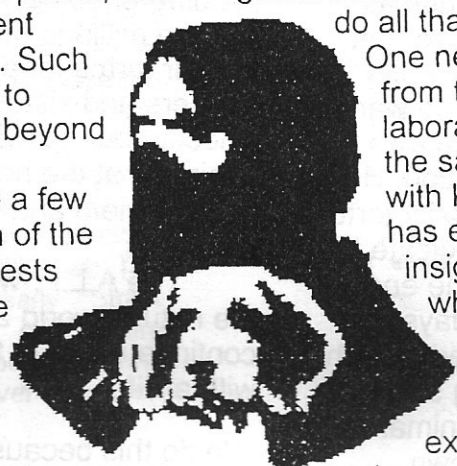
Each of us in our own hearts knows it is wrong to force-feed poisons to rabbits, rats and mice or any animal for that matter but how many of us are willing to violate the "laws" of our society and commit the "crime" of breaking and entering, grand theft, and destruction of property to stop it? Once we cross that line, it takes us from peaceful protesters to alleged felons in our pursuit of the bond to earth and animals. Animal Liberation Front activists face many years in prison, huge fines and restitution, long periods of probation where violations mean more years in prison, and almost always guarantees government harassment for the rest of their lives. Such is the price for taking our opposition to animal abuse and earth exploitation beyond the accepted perimeters of protest.

So why risk all in order to save a few animals and lesson the profit margin of the government sanctioned vested interests who destroy nature? Because we're tired of waiting for others to stop unquestionable evil in this world. We're tired of being dragged from the picket line and watching truckloads of animals going to slaughter, of bulldozers rolling toward the destruction of wilderness animal homes. Where civil disobedience in our movement mostly centers around drawing attention to the abuse and exploitation of animals and earth, A.L.F. actions seek to rescue the prisoners of that abuse and hinder if not cease that abuse by destroying the machines and tools of life's destruction. Though sharing the very same goal, the difference in tactic and total disregard for unjust laws matters greatly

in the eyes of the slanted scales of justice. So why does the A.L.F. continue to participate and advocate tactics and strategies that seriously threaten their personal liberty and physical freedom? Because what we endure in a prison cell or at the wrong end of a hunters or cops gun is minuscule when compared to what our governments allow to happen to animals. Though the A.L.F. may never receive the support or participation of as many who support or participate in civil disobedience and protests, these are some of the reasons A.L.F. activists have chosen to sacrifice certain unnecessary liberties to ensure fundamental liberties for animals.

Anyone who has ever seen video or photographic documentation of animal abuse (often obtained by the A.L.F.) can relate to the feelings of powerlessness and inability to stop the torture. Screaming your lungs out on a protest line and even getting arrested in acts of civil disobedience are ways that we manifest our rage and anger, but often the feelings of impotence return and we are left facing the continued torture and abuse of literally billions of animals. For A.L.F. members a life of obedience to laws and values that sanction the destruction of all we love is no life at all. How can we as fellow members of the same species responsible for such cruelty and global destruction, as we now witness today, not do all that is humanely possible to stop it?

One need only rescue one individual from the fate of the vivisection laboratory or factory farm to experience the satisfaction and peace that comes with knowing that at least one prisoner has escaped. Any feelings of insignificance from such an action when compared to the thousand not liberated are erased as you witness the joy and love for life that all animals are capable of expressing when released from their misery. I will never forget the reward of watching a little female guinea pig I once knew being received with such gentle love and compassion by an elderly women who warned me of animal dealers who kidnap pets for vivisection. Little did she know (or need to know) of the impending fate of our little animal relation had the A.L.F. not rescued her from the vivisection supplier who had already sold her to a lab for LD50 testing. Hundreds of guinea pigs are tortured in vivisection lab's every year, but at least



one wouldn't be

Fighting factory farming can also leave the rage activist feeling overwhelmed when simply seeing a vegan doesn't stop millions of chickens from being forced to live a cramped existence on egg farms. Yet it doesn't take more than even the smallest backyard to build a chicken coop that could be heaven to 6 or 7 laying hens. Many times we have broken into egg farms to help rescue a few chickens who were precariously clinging to life in their squalid conditions, and it has been a true blessing and beacon of hope to see these intelligent animals recover from their confinement. Within days chickens are capable of some how remembering how to dust-bathe, scratch for bugs and worms, and roost at night. Social structure and individual personality returns to all animals when given the opportunity.

When one liberates any animal from a certain death with the guarantee of life incredibly better than any other in its intended fate, a victory is achieved for all who believe in the rights of animals. We remind ourselves and others of the inherent worth of all life and how the values and laws of the society we oppose deny not only animals but also ourselves true freedom.

So open up your home to rescued animals and assist others in finding homes for the liberated. Maybe the A.L.F.'s Underground Railroad will come knocking on your door. And if you know of someone who would feed and care for animals if a coop or other facilities were built on their property then get out there with hammer, nails and recycled lumber and build it. And when its built don't wait for the A.L.F. to find tenants, get out there and get em out yourself.

For the urban guerrilla or activist who wants to really impact the cycle of animal abuse, economic sabotage is the A.L.F.'s salvation. How often we all have stood in front of university torture chambers on that one day a year we dedicate to laboratory animals, only to go away at the end of the day knowing that for the 364 other days that year the animals will be used and abused as if they weren't the living, breathing, and feeling sentient beings that they are. Yet in one night animal research laboratories have been shutdown, hundreds of animals liberated and research experiments ruined by A.L.F. attacks. Though the tactics may appear extreme to the uneducated or unaware, the A.L.F. has always countered that the true extremists and terrorists are those who in the light of day and fully within the bounds of the law, conduct painful experiments on animals. Many above-ground activists find it easier to support live animal liberation's with their happy endings, but for the animals left behind there is no happy ending when the torture chambers are emptied but not

destroyed.

To this day, the greatest impact caused in vivisection laboratories and other A.L.F. targets has been through arson. In June of 1991 when the A.L.F. torched Oregon State Universities Experimental Fur Farm a handful of activists no different from yourself, accomplished every anti-vivisectionists dream. Not only was the 65 year old laboratory shutdown and every research project destroyed, but information obtained from the vivisectors own records helped contribute to numerous raids on other fur farms and laboratories. Most often animal rights activists are mistakenly led to believe that animal research laboratories are secured fortresses, but such is not always the case. All it takes to find out is for every animal liberation activist to adopt a vivisection center in their area and spend late nights observing the nightly habits and routines of maintenance and security staff if any. After a few weeks you may be surprised to discover that a window of opportunity is available, enough to allow liberationists the opportunity to strike. Once you have balanced the scales of true justice by making your own rules in the fight to defend animals and the earth through illegal direct action, you will have discovered what our enemies fear most, the unleashed fury that is the A.L.F.

So why not try pursuing the shortest path to animal liberation? Think of all the risks you would take if your very own dog or cat was being tortured in a vivisection laboratory and then try to explain the difference between you own companion animal and the millions of animals in research lab, factory and fur farms today. Remember, animals are our brothers and sisters in this world. They are innocent beings who know not why they are being punished at the hands of humans. Lets not forsake them and leave them to the fate of the merciless.

The A.L.F. will not forget our connection to the natural world and the animal people and will continue to strive towards a harmonic relationship with all life.

We do this because of love not hate. Governments can imprison us, but they cannot break our spirit. Please join us in our quest for immediate and total animal liberation.

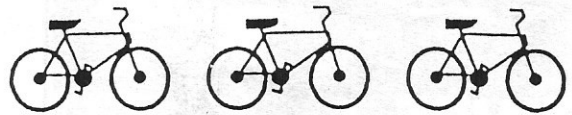
Car Culture & Creating the Critical Mass

Its been happening regularly in over 60 cities around the world for the past few years along with a yearly "Street Party" in which the streets are reclaimed for a longer period of time for the use of humans over the petrol-chemical machine.

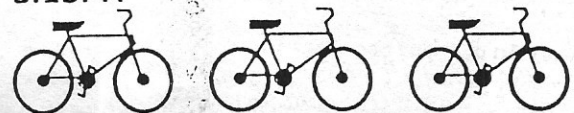

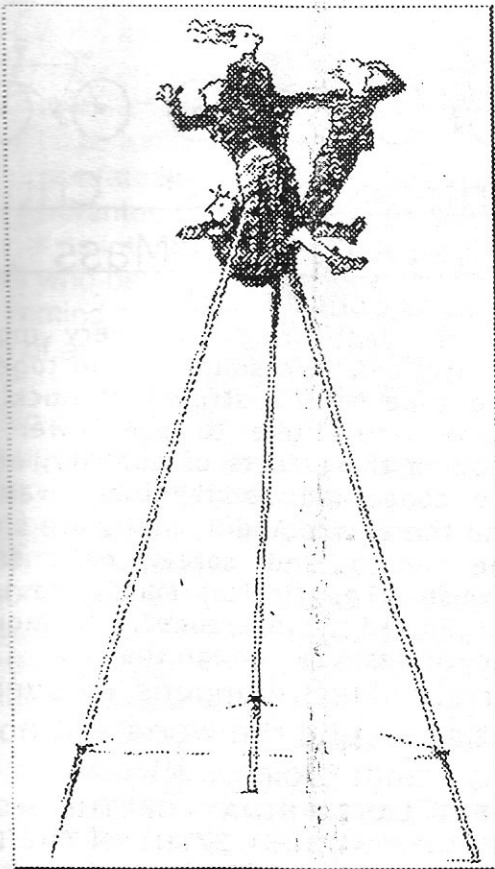

STATISM AND ANARCHY

Author; Michael Bakunin

Statism and Anarchy is the first complete and authoritative English translation of the last work by the great Russian anarchist Michael Bakunin. It was written in 1873, in the aftermath of the rise of the German Empire and the clash between Bakunin and Karl Marx in the First International. Bakunin assesses the strength of a European state system dominated by Bismarck and then, in the most remarkable part of the book, he assails the Marxist alternative, predicting that a "dictatorship of the proletariat" will in fact be a dictatorship over the proletariat and will produce a new class of socialist rulers. Bakunin outlines his alternative vision of an anarchist society and identifies the social forces he believes will achieve an anarchist revolution. Statism and Anarchy had an immediate influence on the "to the people" movement of Russian Populism, and Bakunin's ideas inspired significant anarchist movements in Spain, Italy, Russia, and elsewhere.

DEALING WITH THE POLICE

Anyone can be put in a position where they have to deal with the police. Even if you are part of a non-radical group, the police may approach you for an "informal chat" to gain info on other activists. Therefore this advice below applies to you. The police will do whatever they can get away with. Knowing your rights helps, but don't be too surprised about what they do manage to get away with. Police often try to obtain information from activists on demos while seeming to be making polite conversation. For example they may come over and say "Where are you all from?" or "Who is the organiser?" These may seem like innocent questions, but they can get people into trouble and are helping the police to build up the information in

their files. Such information also makes it easier for scum to infiltrate the animal rights movement by knowing the right names, etc. You definitely should not help them with this. You should say politely that you don't want to talk to them. Police are only allowed to take your details if you have been arrested, if you are driving a car (in which case you have to give the name of the owner of the vehicle), if you are committing an offence or if they have good reason to suspect you of committing an offence (in practice this means most of the time when at a protest). Even under these circumstances the only details you need to give are name, address, date of birth, age (because they are too thick to work it out from your date of birth) and occupation. Do not tell them anything else.

The police may try to question you about an offence that has been committed. Whether you are guilty or not, do not tell them anything. Answering questions will not help you; it will only get you or other people in trouble.

RIGHTS ON ARREST

You will be read your rights: "You are not obliged to say anything, but anything you do say may be given as evidence. You have the rights to consult and instruct a solicitor without delay and to do that in private. You have the right to refrain from making a statement," then be asked if you understand these rights. You should ask for a lawyer immediately and keep asking until you get one. If you don't know of one, you will be offered a duty solicitor. S/he is better than nothing, as a lawyer will be

able to give you legal advice and can help you get released quicker. You probably do not want to tell the lawyer what happened, especially if they are not known to you, and in no circumstances would you implicate other people in illegal actions. It is best to wait until after you are released to discuss your case with a lawyer. You have a right to make a phone call and it is up to you to use it if you want. A drawback of this is that the police will then have that phone number on their files. Obviously you shouldn't tell anyone what happened over the phone - it is likely to be tapped. As with informal questioning at demos, from the moment you are arrested you should say NOTHING except giving your details (as above). To all other questions say "No comment" or when they

first start trying to make conversation state, "I am maintaining my right to silence." When you are processed at the station, the only thing you should sign is for your property, unless you were carrying something 'dodgy' and then you shouldn't sign for it. You may well lose all your property if you don't sign so make sure that is what you want to do. Check through carefully (the police have notoriously unreadable handwriting) to make sure they have a correct list of things and ensure that you sign directly under the list so they can't add anything. If necessary refuse to sign or cross out an item. Beware of seemingly harmless questions. The police will start trying to get information out of you from the moment you

are arrested, including in the car, on the way to the station, in the cells, etc. It is just as important to remain silent during these times, as during an official interview. The police are allowed to take your finger prints and photo, using 'reasonable' force if necessary. It is likely that you will spend several hours in the cells. This is very boring and sleeping helps to pass the time. Be paranoid of talking to anyone in the cells. They may be a police spy or the cell may be bugged. If you are held in the cells until court, always plead not guilty until you have discussed your case with a good lawyer.

THE INTERVIEW

Remember to answer "No comment" or stay completely silent. "No" is an answer, as is nodding/shaking your head.

Police will often try to appear friendly or try the good cop/bad cop routine to stress you out. No cop is your friend - they are all out to get a conviction. At the start they may try to get you off guard by asking "Why did you go to the demo?" or "Why are you a vegetarian?" Once you start to talk it feels impolite/awkward to stop. Also after several hours alone in a cell, you will be more willing to talk to someone. They may say things that are so ridiculous that you feel compelled to counter them, whether its trying to get you to rebutt ridiculous stereotypes/comments about anarchists, or saying things like "the ALF burn down labs full of animals." Don't be fooled into starting talking by this. Still say nothing. Don't let threats succeed.

They may well say that you will be held until you tell them what they want to know or that other people have been released because of making statements. They may threaten to tell your job/parents or that you will go to prison because it is such as serious offence. If you are not guilty and the police know it, they will try to put pressure on you to grass up whoever was guilty. They may even say that someone else has grassed up you. They may say that only guilty people say "No comment" or "This interview is just a chance for you to put your side of the story to counter the allegations that have been made against you." Remember that the only thing you can do by answering questions is incriminate yourself or other people. The time to tell what happened is when you are talking to your

lawyer after release or in court (if the case gets that far).

The police use a great variety of different tactics, which depend on what sort of person they think you are. However you don't have to worry what they are asking, since the only thing you need to do is stick to "No comment". They will soon get bored and the interview will be over all the sooner.

If you inadvertently answer some questions, don't let that stop you from changing to answering "No comment" to all subsequent questions.

AFTER RELEASE

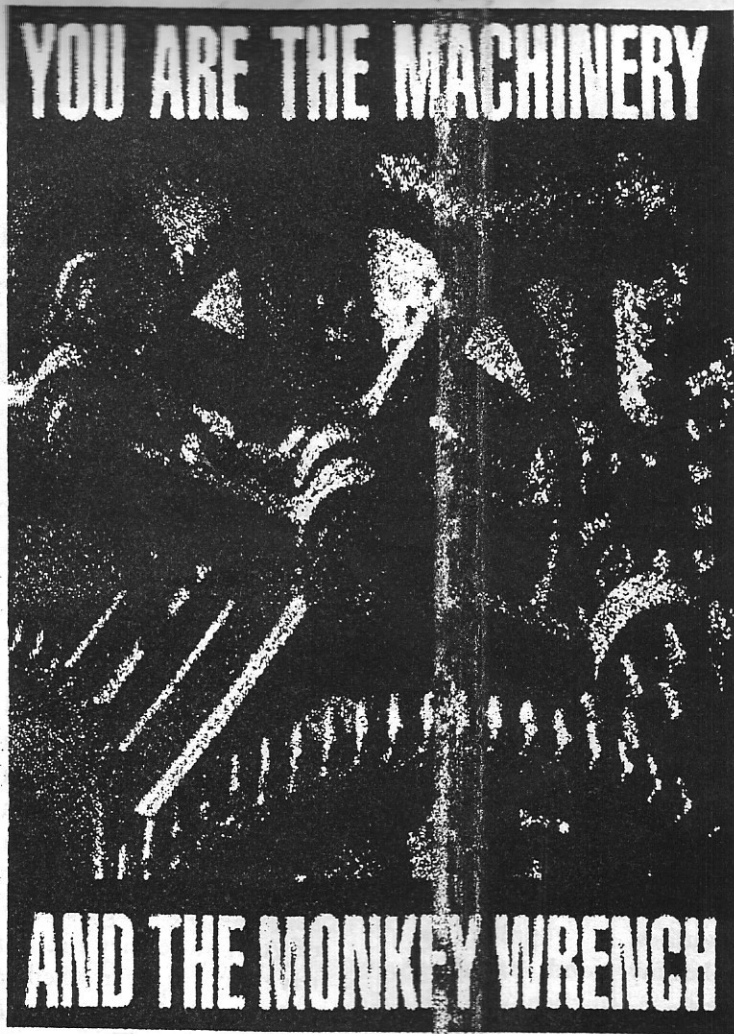
As soon as possible, write down a detailed record of what really happened. If the case is proceeded with, it is likely to be many months before it comes to court and you may have forgotten important facts. If you are released without

charge, talk to a sympathetic lawyer about the possibility of suing the police.

If you have been treated badly, i.e. injured by police or not given suitable food, make a complaint to the Police

Complaints

Authority citing the name and number of the officer involved. It will not help you, but will put a black mark on the officer's record.

THE SUFFRAGETTES

Ever seen the book "The Suffragettes in Pictures", by Diane Atkinson, well it's excellent, full of amazing pictures. The thing that strikes you when flicking over its pages, is how remarkably brave and dedicated those women obviously were. I thought it might be of interest for some of you - especially those who might have been led to believe that women were given the vote - they had to fight for it all the way, and their fight was about much more than just getting the vote...

After years upon years of frustration with campaigning by going through the "proper channels" and getting nowhere they decided to embark upon a course of confrontation with the Establishment by consciously breaking their laws.

They broke windows, committed arson, and rioted in the streets. They showed contempt for the courts, they refused to be frightened by the threat or imposition of prison and when inside prison would go on hunger strike.

They were ridiculed by the media, beaten up by the police, imprisoned in their hundreds, were force-fed in prison whilst on hunger strike. They gave their lives to the struggle.

They adopted the slogan "Deeds Not Words". By the use of their tactics they made a huge impact on Edwardian society and shocked it into reappraising the role of women.

We can learn from the history of those who have gone before us. Exploitation is ingrained in the "System" and through a series of unjust laws. Blind obedience to unjust laws is a nazi's dream - we must reject it and it's what the suffragettes rejected.

Another cool book is called, "My Aunt Edith" written by Phoebe Hesiketh about her suffragette Aunt, and this one will really blow your head off!! Prior to getting involved in the struggle she'd been noted by her family and friends for her meek, mild nature but phewee once she got involved it wasn't long before she became a "full on", hard-core rioting arsonist - a vegetarian one at that! Read the book - its excellent. It's weird how the more you look into stuff the more you see everything is tied together, racism, sexism, speciesism, its all about fighting against oppression, exploitation, violence... Infact when early American feminists would meet up with anti-slave trade campaigners they'd make a toast to "Women's Rights and vegetarianism" and Aunt Edith certainly didn't let me down. "The very word 'slaughterhouse' is so barbarian" she used to say to her niece. She hated the awful violence of the slaughterhouse and the smell of the butchers. And when, later in life, she witnessed the introduction of battery farming - "Those poor birds!" she exclaimed with grief in her voice. "They make them work in factories now".

When the police brutally beat this women, who literally wouldn't hurt a fly, and locked her up in prison for doing no more than taking part in a peaceful demonstration outside parliament it only strengthened her resolve. When the prison chaplain said that he was sad to see her inside she replied "why sorry? I'm proud and glad to be here." All it did was to make her change her tactics. She was to go back to prison on many occasions for such "offences" as burning down the home of Lord Leverhulme (who also hosted a bloodsports fiesta) and attempting to blow up a factory.

"The women who were arrested on Thursday as a result of the scenes arising out of the King's refusal to receive the deputation, were brought before Sir John Dickinson at Bow Street on Friday.

Practically all the women refused to give their names, and were allotted numbers... In the course of the proceedings the strain of 'the Marseille' played on a cornet reached those in court, and suffragists in the cells and corridors applauded loudly... Number one was brought in, and refusing to walk, was dragged in on her knees. She was charged with striking a constable in the face and was bound over...

Then a woman had to be held in the dock by the constable.

Notwithstanding this, she wrenched free, and almost climbed over the dock rail... A bag of flour was thrown and its contents scattered over the court. 'Number 11' pulled off her boot and flung it at the magistrate from the dock. Sir John caught it with his left hand and placed it on the table by his side. She was bound over... 'Number 14' shouted 'Hip, Hip, Hurrah!' when she was brought into court, and continued until she was ordered to be bound over."

"'Deeds Not Words' is the motto of this movement, and we are going to prove our love and gratitude to our comrades by continuing the use of the stone as an argument in the further protests that we have to make... Most important of all... does not the breaking of glass produce more effect upon the government."

Votes For Women 23/2/1912



"On Friday evening, shortly before 6 o'clock a band of women carried such a window campaign in the principal streets of the West End as London has never known. For a quarter of an hour nothing was heard but the fall of shattered glass and the angry exclamations of shopkeepers."

Daily Telegraph 8/3/1912

"The great demonstration of militant suffragists, so long talked of and so elaborately organised, culminated in an extraordinary scene in Hyde Park yesterday afternoon. Never, in the estimation of most experienced observers, has so vast a throng gathered in London to witness a parade of political forces. There must have been over 300,000 people of all classes present, and the majority of them no doubt were drawn by curiosity, as well as by interest in the remarkable personalities of the movement which excited so much controversy in the last few years."

Daily Chronicle 25/6/1908

"Prisoners were held down by force, flung on the floor, tied to a chair and iron bedsteads... while the tube was forced up the nostrils. After each feeding the nasal pain gets worse, so that it becomes the refinement of torture to have the tube forced through. The Wardress endeavoured to make the prisoner open her mouth by sawing the edge along the gums... the broken edge caused the laceration and severe pain. Food in the lung of one resisting prisoner immediately caused choking, vomiting persistent coughing. She was hurriedly released the next day suffering from pneumonia and pleurisy. We cannot believe that any of our colleagues will agree that this form of prison treatment is justly described... as 'necessary medical treatment' or 'ordinary medical practise'."
